Documents required –

- 1) University LL.M. CET Score Card
- 2) SS.C - Statement of Mark sheet & Passing certificate
- 3) HSC - Statement of Mark sheet & Passing certificate
- 4) LL.B (3 yrs /5yrs) - All Semester Mark sheet (including all KT Marksheets, if any) & Passing certificate
- 5) Birth Certificate **and/or** School Leaving Certificate (mentioning place of Birth)
- 6) Domicile Certificate (Must mention place of Birth/Community certificate)
- 7) Caste Certificate for all Reserved Category Candidates
- 8) Caste Validity Certificate for all reserved category candidates
- 9) Non Creamy-Layer Certificate for all reserve category except SC & ST.
- 10) EWS – Economically Weaker Section Certificate
- 11) PWD Certificate
- 12) Defence Certificate

The Qualified Candidates will have to provide their preferences on the LL.M Groups offered by the college. The College will publish the merit list in accordance with the applicable norms and reservation policy of the Government of Maharashtra.
