I, a returning officer, issued the following program for the election for the post of 11 posts of the Executive committee of Vidhi-Bandh, VPM's TMC Law College, Thane's Former Students Association.

Voters List 12th February 2025

The final voter list will be published on College Website on 12th February 2025. Every Alumni who has filled a membership form and has paid Rs.500/- as lifetime membership fee, on or before 12th February 2025, is a valid voter. All the valid members/voters will be made members of the WhatsApp group for further instructions and notices.

Last day of fillings of Nomination 13th February 2025

Every valid member has the right to contest the election and for that they shall submit their nomination as per the format given. (Annexure-I) The nomination form may be rejected on the ground of Incomplete form or submission of forms beyond given date and time or for not paying the requisite fee.

The valid member shall submit their self-attested Nomination form on or before 5 pm on 13th February 2025 with requisite fee of Rs. 500/- only.

The final list of the candidates submitted nomination forms will be published on college website on 13th February 2025 at 8 pm. (After scrutiny and satisfying the objection if any)

Last Day of Withdrawal of nomination form 14th February 2025

The Candidate may withdraw their nomination on or before 5 pm on 14th February 2025. The fee of Rs. 500/- is not refundable.

Final list of candidates 14th February 2025

The final list of the Candidates will be declared on 14th February 2025 at 8 pm. This list will be published on WhatsApp group.

If only 11 candidates or less than 11 candidates only filled their nomination, the returning officer shall declare all them winners unopposed and cancel all further proceedings of the election. In this situation, the returning officer shall issue certificates to such unopposed winners' candidates.

Poll (Online Mode) 15th February, 2025 (1 pm to 5 pm)

The election for the 11 posts of executive body of Vidhi-Bandh will be held on 15th February 2025 in following mode;

The election will be conducted online

The valid voter will receive a link of voting by 1.00 pm in the WhatsApp group created for valid members/ voters. The link will remain active till 5 pm. (The link will be closed in between 5 pm to 5.05 pm)

The returning officer will notify the total number of votes casted at 7 pm on 15th February 2025.

Mode of Voting

The link of voting will be posted on WhatsApp group created and shall remain active from 1 pm to 5 pm.

The valid member/ Voter shall cast their vote only to one candidate. It is mandatory for each voter to respond to all the questions in the voting link.

Result

15th February 2025, 8.30 pm

The Result will be declared by 8.30 pm on 15th February 2025 and published the same on WhatsApp group as well as on college website.

The top 11 members shall be declared as winners.

In case two or more than two candidates received the equal vote, the draw will be conducted in presence of Principal of the College.

Issuance of Certificate to Winners

The returning officer shall issue certificate to all winning candidate in the format as shown in Annexure- III
